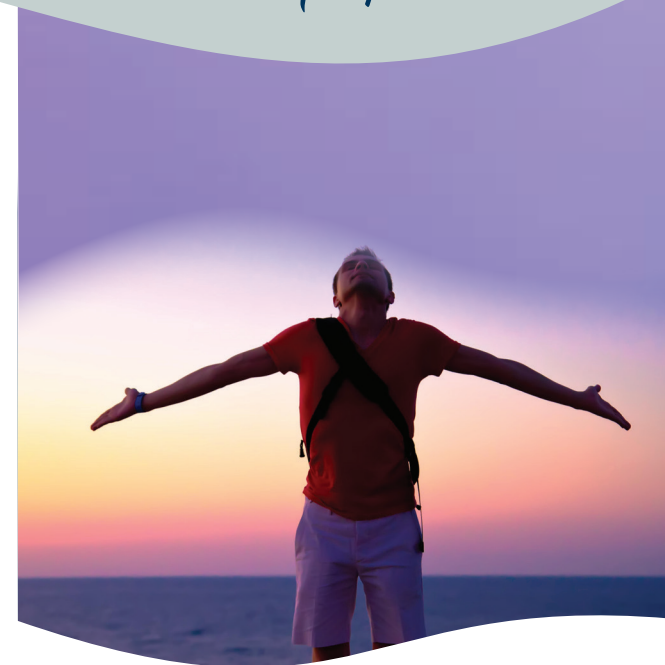

Ways to Heal...

I can choose to give in many ways.

An **Outright Gift** is usually a gift of cash.

Tribute Gifts in memory of a family member or friend, in honor of an individual or in recognition of a special occasion.

Gifts of Life Insurance. I can purchase a new policy or donate a policy that I currently own, and designate WMC as a beneficiary of the life insurance policy.

Will or Trust Bequest allows me to establish my wishes today. The bequest may be a fixed dollar amount, a bequest of specific property, a bequest of a specific percentage of a person's estate, or a bequest of the residue of a person's estate.

Endowments. The Winneshiek Medical Center has two endowment funds with the Community Foundation of Northeast Iowa. Contributions to our endowment funds are eligible for a 25% state tax credit in addition to the federal tax deductions.

Charitable Remainder Trust is a special trust that pays income to family members. After all the income payments are made, the remainder is distributed to qualified charities such as the Winneshiek Medical Center Foundation.

Gifting Through Retirement Plans If the foundation is named as a beneficiary of a retirement plan or IRA, the assets will come to the foundation after the retiree or retiree spouse's death with minimal estate and income tax reductions.

Matching Gifts Many employers have matching gift programs through which a gift to the Winneshiek Medical Center Foundation can be multiplied.
